### How long we store personal data

SoccerPLAY does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. For this we use the following storage periods per purpose:

1. Sending the newsletter and e-mailing:

Storage period: as long as necessary

You can unsubscribe yourself from the newsletter or e-mail at any time by clicking on 'unsubscribe'. You can also send an e-mail to [info@soccer-play.com](mailto:info@soccer-play.com). Your data will be deleted immediately after deregistration.

2. Execution of the agreement:

Retention period: 7 years

We carry out inspections at every notification to prevent labour crowding. For these checks it is necessary to keep this data after the agreement. In addition, there is the legal obligation of 7 years from the tax authorities.

3. Answering quotation requests:

Storage period: 3 years

With every outgoing quotation we store simple personal details such as name, email address and telephone number of the applicant. As a result, we can make the handling proceed faster in the future.

### Sharing personal data with third parties

SoccerPLAY will only provide your data to third parties if this is necessary for the execution of our agreement or to comply with a legal obligation. If we provide your data to third parties for other reasons, we are obliged to ask you for permission first. With organizations that process your data, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. SoccerPLAY remains responsible for this processing (s).

SoccerPLAY provides in any case personal data to the following parties:

SmartGoals: they manage the data on a secure server. All data is stored here encrypted. This means that the data is not immediately visible.

CoolCreations: they manage the data on a secure server. All data is stored here encrypted. This means that the data is not immediately visible.

Preau Sports: they manage the data on a secure server. All data is stored here encrypted. This means that the data is not immediately visible.

### Cookies, or similar techniques, that we use

A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. SoccerPLAY uses only functional and analytical cookies. These are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

### View, modify or delete data
